COMMITTEE REPORTS

ARCHITECTURE & PLANNING

CHAIRMAN: GWYTHER JOYCE (01737) 249434

As reported in December's A&P Newsletter, the Reigate & Banstead Core Strategy Examination was reconvened last year on December 10th 2013 at the Town Hall by way of a post hearings amendment consultation to examine detail points of the original hearing. The outcome of the Inspector's review in February was to declare the Reigate & Banstead Plan has been approved in all aspects, as published in the Surrey Mirror.

However the furore in subsequent issues of the Surrey Mirror more recently demonstrates the confusion in Government over the issue, following comment coming from Nick Bowles the Government Minister responsible for Planning in his letter of 3rd March, directly criticising the Inspector for his handling of the examination into the Reigate & Banstead local plan. Specifically Mr Bowles points out the Inspector should have ensured the plan reflected government policy, which by inference it therefore did not, and the essential issue that planning bodies should maintain key protections for the countryside, particularly Green Belt was not made clear by the Inspector.

Logically, it would be expected the Borough should immediately prepare for their planned upcoming review by re-considering their position and reduce proposed construction so as to avoid the risk of having to build on Green Belt land in the future. Perversely this seems not to be the case with Cllr Miller quoted as stating the proposed number of new builds for the period should remain unchanged.

We have repeatedly made the point to the Borough that over many years it has deliberately followed a path of building large numbers of

dwelling, to a greater scale than any other nearby Borough, resulting in Reigate & Banstead being the most densely populated non-metropolitan borough in all England. Inexplicably, this scale of permitted building continues which will potentially be at the cost of irreplaceable Green Belt land as brownfield and windfall sites become more and more scarce.

Equally discouraging is the cause very much at the heart of our society, that of Reigate Priory repair works. For months there has been little or no activity, however towards the end of February there has been evidence of action by renovation specialists.

On a brighter note, we are very pleased to see the original lettering returned to the shopfront of Knights on Bell Street in January this year as a result of the determination of the Borough Conservation Officer lead by Mr John McInally. This outcome has been a long time coming however it is good to see an example here of some of the irreplaceable elements of the detail fabric in our Conservation Areas retained, protected and returned to their rightful position.

The Reigate Signal Box plan of action seems finally to have run into the 'buffers', as Network Rail stated position is that its proximity to the track will make it an ongoing liability and that it will not be possible to recover the costs of that liability. Furthermore they state the proximity of signal box to moving trains makes it unsuitable for any function outside the railway industry and therefore once current usage ceases, demolition will be

very likely. Our Society hopes to find another option, but the only currently apparent one of relocation appears financially prohibitive.

Redhill Aerodrome hard runway redevelopment has yet again been thrown out on appeal and provides at least one bright spot in the battle to

save Green Belt land in the Borough. How strange that this part of 'Green Belt' is protected while other areas are to be earmarked to be built on as approved under the flawed Core Strategy Examination.

REDHILL

CHAIRMAN: GERRY MOSS (01737) 765508

Probably the most obvious new development in Redhill is the first stage of the Balanced Network scheme. This has involved reorganisation of the Lombard roundabout ready for two-way traffic. The next phase will involve St Matthews Road and Station Road, which will become a three-way, traffic light controlled, junction. The final change to two-way traffic is at present expected to be in July. The reduction in the size of the station roundabout to provide more "pavement room" for cyclists, together with the reduction from two to one lane for cars entering the town from the east under the railway bridge, will negate much of the traffic flow gains from two way working. One change, of much to concern to the Committee, is the removal of the centre island at Gloucester Road by the Lombard roundabout. Some drivers do seem to recognise that the raised platform is used by pedestrians to cross. It is to be hoped that a safety audit will improve this situation.

Work is due to start shortly on the Memorial Park. In order to complete the work as quickly as possible the Park will be closed for about six months. Panels are planned to be placed by the entrances to explain the significance of the Park as a memorial to the First World War. It is hoped to use the park for an event to mark the start of the First World War in November.

Two other developments in Redhill include Asda which has finally withdrawn from the Cromwell Road site. This area is probably going to no longer be zoned as a super market site. Development of the Liquid and Envy site seems now to be going ahead with a Tesco Express shop.

Plans for Station Road East are now clearer. It will be closed to traffic except for authorized users. New disabled parking will be provided in the Marketfield Way development. Subject to CCTV requirements addition trees may be planted between the Station roundabout and Maple Square. The trees in the centre of the roundabout will be retained.

Plans for the Marketfield Way site (the Marketfield Way car park through to the High Street) are now conceptual plans. The *Surrey Mirror* pictures showed it from across Marketfield Way. The plans show that the basement level will be for residents only; larger shop units on the ground floor; six screen (or more) cinema on the first floor; and about 90 new homes above. It is not clear where people coming to late night cinema showings will park. The other aspect is that it is not clear where traders in the High Street market are going to park their vans. Until a planning application is submitted it is probably too early to worry about the details as everything will probably change. However the market and cinema parking problems do need to be addressed.

It is expected that the redevelopment of the Station car park, behind the Toby Carvery, is likely to start soon. This multi-storey car park will need to be finished before work can start on redevelopment of the station car park on the west side. A welcome development is nearing completion at the station with refurbishment of the two lifts and adding a third from the booking hall to the cross passage.

TRANSPORT

CHAIRMAN: JOHN CHITTENDEN (01737) 242328

Gatwick & Heathrow Airports. Sir Howard Davies, Chair and Leader of the Airports Commission, recently stated that further public consultation will be launched next Autumn. RS report No. 50 may need to be updated. Comments are requested. In the mean time the commission will investigate

transport and, hopefully, drainage at both the airports.

Flooding & proposed population expansion.

Recent flooding within the Mole valley flood plain, both within the Borough and our two adjacent L.A.s of Tandridge and Mole Valley may present a

long term problem.

New housing, industry, schools and hard paved area development may increase the rate of storm water run off reducing the time of concentration within the rivers Mole and Eden. If the new Gatwick proposals go ahead involving new runways, paved areas, car parks and industrial sites this will also reduce the time of concentration of storm water.

Legislation requires county councils to approve, adopt and maintain SUDS, drainage systems and balancing ponds supplied by the developing contractors and providers of new housing, including airports, the cost of doing so in an effective and efficient manner may prove to be costly.

Should sea levels continue to rise at the rate of 3mm/annum it may prove necessary nationally to

follow the Dutch example of widening river outfalls so that maximum discharge can be achieved at low tide and with flood gates to prevent incoming rising tides from flooding low lying land and estates.

Roads & Transport.

Apart from the damage to bridge structures, floods also damage road foundations. The ingress of water into the subsoil turns the earth to mud with no strength to support the road foundation. In the Spring we are likely to see areas of failure that should be reported to the Highway Authority in the interests of road safety.

The Inspector's Report to R & B BC dated 31.01.14 is available. Some of the details are recorded in Report No.54 which is available on the RS website.

NATURAL AMENITIES

Priory Park. Most people will have heard already the news about the Right of Way (ROW) from Bell Street to Morrisons. This was approved at the last meeting of the Local Committee comprising both borough and county councillors despite vigorous opposition from the school. Although this is a major step forward it is not the end of the story because, under the complexities of ROW law, the route could still be the subject of a public inquiry if objections are registered even though the order has been signed. Any Inquiry would require further supporting letters from members of the Society and supporters of the ROW to ensure the order is upheld.

The repair work on the Priory building mentioned in the A & P committee report has resulted in the installation of two structures within the school site which do not have planning approval. The Society is monitoring the situation to ensure that proper procedures are followed by all parties and that these structures do not become permanent by default.

Reigate Heath Ian Wright and his Countryside Team are proceeding with the schedule of works and have the help of the Reigate Area Conservation Volunteers (RACV). A new Information leaflet about the Heath and its management has been produced which is available from the Town Hall and other outlets

including the leaflet holder on the Cricket Pavilion on the Heath.

The RACV have three work days scheduled for Reigate Heath before Easter so do look out for them if you are on the Heath on March 23rd which will be the final work day of the three.

A Reigate Heath Residents' Association has been formally set up and is represented on the Reigate Heath Management Steering Group for 2014. The Reigate Heath Residents' Association Constitution (10 July 2013) states that the area of interest includes properties and land comprising Flanchford Road to the north of the junction with Clayhall Lane, Bonnys Road, Reigate Heath, Heathfield, Trumpets Hill Road, Sandy Lane, Buckland Corner, Buckland Road, Cliftons Lane, Colley Manor Drive and Colley Lane. Residents of these roads are automatically members. Relevant planning application details are circulated to the group. Contact: reigateheathra@gmail.com to give your contact details.

Buckland Sand Pits. It is believed that sand extraction is to cease during this year but this has yet to be confirmed. If true then it will help to restore the much lowered water table. This may have happened to some extent already after this winter's rainfall as surface water has been seen lying in places which have not been wet for years.

BOOK REVIEW

My side of the fence by Jeremy Early

This book relates to the observations of the flora and fauna either in or visiting, one Reigate garden. It runs to nearly 250 pages and every page contains at least one photograph, many with more.

The quality of the photographs, virtually all taken by the author, is outstanding and, when combined to the accompanying text it makes it an easy read and source of reference.

The book is divided into chapters covering the whole spectrum of wildlife from mammals to invertebrates, again with amazing photographs and a comprehensive catalogue, including their Latin names.

The first chapter covers the flora and habitats, although the following chapter covers ponds, which I thought should be included as a habitat, but a small point. Otherwise the chapters are set out in a logical and easy to follow format.

The time, patience and effort that has gone into producing this book is staggering and results in a book that will enable others to easily identify and appreciate the flora and fauna in their own garden without this effort.

I would suggest that this handsome book be kept near to where you can observe your garden as a handy reference to the visitors or inhabitants of your garden.
