It was a pleasure to attend the last Redhill Committee meeting and the Solum development consultation see what great work Pippa Martin's committee are doing with their knowledge and expertise in Redhill. Redhill is currently in the process of having major redevelopment carried out and while the extra attractions, retail space and residential units are overall welcomed to increase interest and footfall to the centre, we need to be mindful that mistakes of the past are not repeated, and quality places and connections are made that enhances the town.

It was also great to see the Green Spaces Group's 'Greenaissance' document presented and the continued good work that they are doing to protect our green spaces.

Reigate Tunnel:

The old Tunnel in Reigate is 200 years old this year and this is being marked by an event in July with many different displays and exhibitions planned by the Reigate Business Guild. Our very own Nicholas Owen has been attending some Reigate Business Guild meetings and met with the Chair, Spencer Copping and along with Bruce Healey, Chair of the Transport Committee, have offered the society's help in supporting this.

TREASURER'S REPORT –ROBERT BOGIN

There is a net deficit of -£602 for the year ending $31^{\rm st}$ March 2023. There have been exceptional expenses in the year to date i.e. £2050 regarding the plaque and sculpture in Priory Park and some further cost relating to the brick floor to prevent pooling of water within the arc of the seat. The actual cost to install the plaque was donated by Stanton Construction. The Heritage Open Days brochure cost was £2362 however advertising in the brochure brought in £900 and the promised donations of £1450 from 3 local Councillors finally materialised leaving a deficit of £12. The Members' Meeting/AGM showed a net cost of £148. The balance sheet figure as at 27/03/23 is £11,984. Subscriptions were £3520 down £440 on the previous year.

REGISTRAR'S NOTES -ROBERT BOGIN

Number of paid up members stands at 360 comprising 95 single memberships, 119 family memberships, 20 corporate and 7 others. Thus total of 241 memberships. There are still 43 memberships who have not renewed representing 64 members

This represents a drop in membership of 101 members, 76 memberships in the last year assuming that no more renew before the end of March. The Treasurer will send out final notices of ending of membership in April and all details of those members will be removed from the database within 3 months.

COMMITTEE REPORTS

ARCHITECTURE AND PLANNING COMMITTEE – TIM LEE

The Civic awards 2023

The committee is currently preparing the nomination list of buildings and projects for this year's Civic awards. Once a list has been drawn up, the relevant parties will be contacted and judging will be arranged before we meet to decide on awards and commendations.

The new and improved judging criteria will be applied this year which has been revised by the committee to take into account aspects of design, regulations and technologies prominent in the 21st century.

We look forward to holding the awards ceremony at the AGM in June or a separate event in September 2023.

The New Priory School:

The planning application for a new Priory school on the south part of the Woodhatch place site was REFUSED at the Surrey County Council's planning committee on Wednesday 22 February by a vote of 4 to 3 in favour of refusal. The committee meeting was attended by me via weblink.

This outcome means the school and Surrey County Council need to consider a resubmission of a revised planning application taking into account the reasons for refusal. There is also the option of meeting with members of certain campaign groups and the Borough Council to discuss a revised 'hybrid' scheme for the current site which would involve refurbishing the existing Victorian part of the Priory building and developing the site that currently holds the 1950's building.

The committee's development appraisal document is just being finalised and will be presented and discussed with the Borough council in the next couple of weeks.

The Solum Development of Redhill train station:

Pippa Martin kindly invited Tim Lee and the APC to a consultation meeting, set up by the Redhill Committee, with members of the Solum development of the Redhill train station. It was a very productive meeting and a great chance to see in more details the plans for the two sites either side of the railway bridge.

The main concerns towards the development are the 19 story high tower block which is part of the developer's 'landmark' building concept but in reality is grossly out of scale to the rest of the Market Way development buildings. The need to incorporate more greenery around the site was expressed as well as the need for the whole of the transport hub including the bus station to be looked at coherently as well as including refurbishment and improvement of the railway bridge which connects the two station sites. We hope that some amendments will be made by the developers before a planning application is submitted later this year.

The Angel pub:

The Angel pub development seems to have all of a sudden come together quite successfully and the work that has been undertaken on the existing pub building looks to be of good quality and has been carried out by specialist heritage contractors which is encouraging to see. The new black timber clad residential building is also looking more complete and reflects a historical building once standing on the site which had been removed previously.

REDHILL COMMITTEE - PIPPA MARTIN

A meeting at The Belfry was attended by Tim Lee (Chairman R & R Society) David Paxman, Gerry Moss, Jonathan White, Richard Webb, Helen Neve, Jonathan Essex, Chris Ingram, Steve McKenna, Andy Nash (Manager the Belfry)), Sue Sinden, Pippa Martin (Redhill Committee Chair). Apologies were received from Martin Bacon and Helen Burr.

Following the change of name of the Society to THE REIGATE & REDHILL SOCIETY Tim Lee suggested that we have an event in the near future to celebrate the collaboration.

Andy Nash reported that the footfall in the Belfry had held up at the end of 2022 and compared favourably with other similar shopping centres. There is evidence that people are shopping a little less with Amazon and online. He showed images on the screen of Banbury shopping Centre created by 'The Light', the developer for Redhill Marketfield Way.

The Light plan a 6 screen cinema – the first film showing will be Indiana Jones in June. Also a climbing wall, bowling alley, karaoke and 4 food outlets. The leisure attractions will be open at night and Andy Nash reported that the Belfry car park will remain open at night helping to make Redhill an attractive town in which to live, visit and work. The cinema will be cheaper than Everyman. The front face of the building is on the pedestrianised town centre and new "galleria" arcade. Target opening June 23.

Jonathan Essex will feed into council the need for better advertising at of the Harlequin at street level and throughout the town. The Harlequin serves local community events and houses rehearsal space for Surrey theatrical groups. It also provides specialist films eg live broadcasts and recordings from The National Theatre, Covent Garden etc.

Parking should be extended beyond the present maximum of 3 hours.

REDHILL COMMITTEE – PIPPA MARTIN (continued)

There was a question about the future of the library; Jonathan Essex confirmed it was under discussion by RBBC.

It was suggested that there should be restrictions on feeding pigeons in the centre. Attractive new paving with box planting has been laid between the Picture House and Marketfield Court. The estate agent Andrews who have been in Redhill for over 50 years have moved to Reigate and are to be replaced by a barber!

On 19th January Jessica Ferguson of Reigate and Banstead council reported that a new Local Development Scheme had been approved on 27th October 2022 superseding the June 2019 scheme. It is available on the Council's website and in hard copy at the local libraries.

Richard Webb and Helen Neve presented their detailed "green strategy proposals" on the screen for the "greening" of Redhill. They showed plans of Redhill highlighting "quick wins" and more ambitious targets. The aim is to draw a bid team with a pitch for funding (eg Biffa, CI funding) with specific ideas. Possible link to new Redhill/Horley design code feed in ideas for a healthy community and inform new local plan. The aim to get people talking, stimulate ideas, the arrival experience of Redhill, biodiversity and green spaces. Images were shown of Sheffield with reduced road width and "8 to 80" attraction, Redhill Brook reimagined, rooftop greenery etc which would be standard in London planning. Why not well designed and interesting architecture in Redhill linked to water? The night- time economy should improve the barren and dreary centre at night. All invited to share ideas, consultees and funding schemes. Richard Webb and Helen Neve to approach RBBC and SCC.

Jonathan White opened the discussion on unsatisfactory parking in Redhill. Especially near McDonalds and the roundabout where couriers and taxis hover. It was agreed that parking on the pavements was quite unacceptable and should be illegal. The problem would worsen once the new development was completed. Jonathan Essex suggested that Jonathan White raise this with Surrey County Council as the traffic problem needed radical changes.

The Surrey Mirror on Jan 12 reported that there is some shift on the Government's plans on the Green Belt in a national consultation on policy framework.

It was confirmed that the Pilot's Hub Café on Redhill Aerodrome is to close. It is understood that the owners of the Aerodrome wish to control the site and restrict admittance by the public. A successful campaign was conducted a few years ago to prevent 8000 houses being built on the aerodrome which is within the green belt.

The Salvation Army Citadel - The Chairman of the Committee reported that despite several emails and phone calls to Matthew Sadler of Sibley Pares who is responsible for the sale there has been no response. Pippa Martin to send a letter on RRS headed notepaper. JW suggested the Plunkett Foundation might be approached..

The White Lion Pub – There is a FB Group to protect the pub who organised a clean up; they could possibly be engaged on the Citadel. There are submitted plans to change the status of the pub to 1 residential and 2 semis in the car park.

The Committee agreed there should be a tree planted on the border of Redhill and Reigate. To date the Council has not responded to permission or the ownership of the land opposite the Church – additionally to celebrate the King's Coronation.

It has been agreed to press for a civic nomination for the YMCA.

Solum, the developer in combination with British Rail plan 266 residences and to redevelop the station area. They also offered a special meeting with the Society which will be arranged in the near future.

John McInally Head of Places and Planning for RBBC has compiled a 37 page report on proposed new conservation areas and extensions for the Borough. Steve McKenna, borough councillor, attended the consultation meeting. At present there are 24 conservation areas.

GREEN SPACES GROUP – MARTIN BACON

The Group has continued to put pressure on Reigate and Banstead Council to give much greater priority to nature within its strategy and budget-making. Vision and ambition are though still in short supply and the preparation of vital management plans for our beautiful open spaces is almost stationary. The Group succeeded however in obtaining a meeting with the Leader of the Council early in the New Year which was also attended by the Chairman of the Society. It was a cordial meeting which resulted in the Group obtaining an agreed quarterly means of communication with senior members and officers. A discussion about forthcoming mowing regimes and communication with residents will be high on the agenda.

The highlight of recent weeks has been the publication of the Group's green renaissance strategy for Redhill Town Centre. The document has been circulated to all Society members. Its issue has coincided well with public debate about the Solum scheme for Redhill Station. The town centre needs an updated vision and strategy if development is to be led by local people and their representatives rather than the development industry. The Redhill Committee is currently leading a debate about the future uses and appearance of the town centre into which the Group's greening strategy is an important element.

TRANSPORT COMMITTEE - BRUCE HEALEY

Roads and Buses

Reigate Tunnel is 200 years old this July and preparations are under way to celebrate the occasion with (hopefully) an array of cars of all ages, some buses, a horse bus, a bar to serve beer, displays etc. The Reigate Business is taking the lead on this but Nicholas Owen and to a lesser extent Bruce Healey have been assisting. The next Reigate Society talk will be on the background story to the tunnel (which is the oldest road tunnel in UK). The annual pot-hole season is in full swing. It is unclear what the situation is throughout the Borough. Some months ago, it was necessary to reroute some buses because of damage from potholes. This situation is nothing like as bad as it was. Usually March is the worst time for potholes although this year perhaps the worst has already passed, although some roads are still bad.

Bus services are back to normal following the COVID lockdowns helped by the Government's £2 cap on fares.

Planes

The number of flights is still considerably below pre COVID levels owing to the economic downturn.

Railways

The good news is that the improvements to Gatwick Airport Station are nearing completion. Beyond that there is little positive.

The 4 car class 769 units have not been a success and plans to use then on the North Downs line have been dropped. Passenger numbers are still well down during rush hours although leisure travel is showing an increase. Overall, fare receipts are well down and the Government has curbed spending. There are unconfirmed reports that the Croydon area improvements have been delayed and plans for Reigate Platform 3 might have been dropped altogether.

On the North Downs line, plans for 3 trains her hour in each direction have been dropped until passenger numbers increase.

There is slow progress on the promised fares review.
