The OVERARCHING PRIORITIES of the SOCIETY are;-

- 1.0 The protection of the GREEN BELT for the long term benefit of future generations. See RS Reports No 44 & 46 together with previous letters and minutes of meetings.
- 2.0 Opposition to the expansion of GATWICK AIRPORT; Because of;
 - i The Increase in Noise and Air pollution.
 - The proposed and subsequent land take from the Green Belt.
 - iii Support for the **petition** submitted against the Green Belt land take.
 - iv Support for the arguments set out by The London Green Belt Council and GACC..
 - v The Arguments set out in the RS Report No. 50 Gatwick & Sustainable Energy.
 - vi. The inadequacy of the Transport Infrastructure [See previous RS Tpt. Reports]

3.0 OTHER ISSUES DRAWN TO THE ATTENTION OF THE SOCIETY THAT NEED TO BE REVIEWED.

Complaints about Traffic density and speed in Reigate High Street, and at Woodhatch, with dangers to pedestrians from traffic, noise and air pollution. With the Population expansion proposed and agreed by the INSPECTOR these traffic problems are likely to grow within the LEP area and adjacent Districts.

Alternative Transport planning solutions need to be implemented [see reports No. 58, 59 &64].

Education facilities are reported to be in short supply and new facilities will no doubt be required for the existing and new populations. New school sites need to be selected and allocated for new communities at the planning stage. Sites need to be located away from heavily trafficked routes with high noise and air pollution. But provided with safe routes to School for both pedestrians and cyclists with the provision of off street parking.

Rail and Train Services have been the subject of complaint and increased capacity may be required depending on the employment plan for the new population, [see RS report No. 49 SURREY RAIL STRATEGY].
