As recorded in the minutes of the last Council meeting on 5th February I have accepted the Chair of the Society for one year. It is my hope that the Civic Society will raise its profile in the Borough and will during the year enlist a new and younger membership. To this end we must print a membership form with attractive images of Reigate and Redhill stating our aims and objects to foster appreciation and pride in our surroundings and the environment of the Borough as laid out in our Constitution. I have discussed this with Chairmen of similar societies, the general public, tradesmen and colleges and meeting a favourable response.

On Saturday 11th May I was invited to Founders Day at the Royal Alexandra and Albert School and spoke to many guests and visitors. None had heard of the Society! We plan to have a presence at the Festivals in Reigate in May and June. We were invited to find a member to talk on the history of the Borough to the residents of Wray Common Nursing home and recruited the home to membership. As the Society has to be apolitical I invited Rebecca Paul the conservative candidate for the General Election to coffee and talked at length about the aims of the Society. When we have a membership form she will join. Subsequently I have spoken to her on several local issues.

The Borough Council plans a £3m park refurbishment plan north of Redhill and south of the M25 set to open in January 2025.

On Monday 18th March there was an excellent Zoom meeting on the bridges of London and on 20th May Alan Mortlock spoke at the Reigate Community Centre 7.30 on the History of Gatton Park. This meeting was well attended.

ARCHITECTURE AND PLANNING GROUP – TIM LEE

Planning applications & developments

APC continue to meet monthly to discuss live planning applications. One application is part of a consultation for a Surrey County Council proposal for a new school at the former care home on Park Hall Road in Reigate. The APC feel that the construction of a new school facility on the site is positive as it will bring together a needed facility that is currently spread over several other sites and that the design is for a modern, brick-built building that will not impact its residential setting on a currently disused site. On the negative side, the school will bring an increase traffic levels both for local residents and on Reigate Hill and there will be an increase in noise for local residents at certain times of the day. The news that M&S is going to be moving out of the Belfry is a concern for the future of the Redhill shopping centre. The rear is that there will be a struggle to find alternative companies that will be willing to pay the relatively high rental rates to fill such a large floor area. In the same way as the light has been designed, the Belfry will likely need to diversify into different uses to keep up levels of footfall.

The New Priory School

Currently there is no sign of a fresh planning application due to be submitted for a new school on the Surrey County Council site in Woodhatch.

The Civic awards 2024

THE REIGATE PRIORY MUSEUM

Some members may be wondering what has happened to the Reigate Priory Museum, or, if you are new to Reigate, whether there is a museum here at all. A brief update therefore is necessary to clarify this matter.

The Reigate Priory Museum was founded in 1973 by Audrey Ward, a teacher at the school, as an integral part of the school and as part of the wider Reigate Priory Museum Society. It became a busy local museum with changing exhibitions, promoting an understanding of both the historic Priory building and its successive owners, and the history of the town. The Museum has a large collection of items relating to both local and social history, with an important collection of costumes, many given by local people. Exhibitions have always been presented in the Priory's 19th century Palladian-style library, the Museum's display room, to which there is a separate purpose-built entrance at the west end of the building. The most historic part of the building is the Holbein Hall with its staircase and spectacular murals, restored 20 years ago at the initiative of the then Mayor of Reigate. The Museum has an obligation to conduct members of the public to view the Holbein Hall on certain days in the week & on special occasions. The Museum's current long serving curator is Eileen Wood.

Unfortunately, in late 2010 there was a severe flood from the ceiling of the library, caused by snow and poor upkeep. The Museum was forced to close, and its contents hastily removed. Subsequent investigation by Surrey County Council revealed that many rooms in the historic south front of the building used as classrooms, including some upper rooms used by the Museum for storage of its collection, were unsound. A long period of work ensued to repair and make safe these areas, largely completed around the time of covid, at which time, understandably, the school requisitioned the Museum for distanced classroom space. Since then, the dilemma over plans for relocating the school - or otherwise - have prevented the Museum being allowed back into their own premises. The Priory buildings belong to the Borough Council, though SCC have a long lease on the building which includes specific permission for the Museum. Sadly, despite promises, neither the Borough, the County Council or the School can give any assurance for the Museum to reopen, and in consequence the Priory, the inhabitants of the town, and its visitors, are all deprived of the only Museum in Reigate. Surely not a situation for which our Elected Representatives, nor their Officers should feel the least bit proud.

The Museum Society continues to meet with a series of talks and indeed welcomes new members, and many volunteers will be needed to assist if and when the Museum is allowed to reopen. REDHILL GROUP - PIPPA MARTIN

Report of Redhill Committee of the R & R Society

The past months have been mixed for Redhill. The Rise and Light have been popular with both residents and visitors. The cinema has offered a wide range of films in the very luxurious auditoria. The market has struggled to keep an upbeat profile. Tony who ran the flower stall has given up but the Fosters who run the vegetable and fruit stall say they will introduce flowers. They also intend to open a farmers market in the pub which hosted the Vinci offices during the development of the centre.

The loss of the Harlequin and the library due to RAAC has been profound. The library reopened on April 22nd in temporary accommodation in the Consort Building owned by Surrey County Council. Roof repairs are being carried out on the old library building and there are plans for it to return next year. The Harlequin poses a different problem and detailed reports and discussions on viability are under way. The Chairman has pointed out to Council several times that live theatre and a community meeting spaces are vital to a thriving town. Live screening of National theatre, ballet and opera were a feature at the Harlequin. Schools, drama groups, music societies and concerts all performed there. The business guild held its meetings at the Harlequin.

There was a serious stabbing in the Quadrant last month and buildings were smashed in a separate incident. It is necessary that there should be areas in the centre where people can relax and enjoy a varied culture. The Busy Bean Café and Posidero Lounge provide food and drink and Park provides open space but the Borough must have live theatre. There are excellent concerts in the local churches but the Harlequin used to stage professional theatre and talks by renowned speakers.

The news that Marks and Spencer plan to pull out their key store in the Belfry is a big blow for Redhill. Retail stores are struggling and the Council has to do considerable replanning. Andy Nash still manages to keep the Belfry lively and has moved free table tennis into the Samuel the jewellers building and the Pound Shop has moved into the vacated Wilko premises.

On 20th March the Chairman, Pippa Martin, Helen Neve and Tim Lee met with Solum to discuss their revised plans for the Redhill Station. They viewed the new proposals which lopped off 3 storeys from the skyscrapers but were still totally unacceptable. Disturbingly Solum viewed Redhill as "low priority and very much the poor relation of Reigate". The Chairman reiterated her proposal for a pedestrian bridge from the station to the centre of Redhill.

What is Happening with Reigate Level Crossing?

At present, the traffic situation at the level crossing is as good as it has been for many years. Pressure from the Transport Committee via the local Community Rail Partnership has eventually caused Network Rail to look at the operation of the crossing with the conclusion that there were no procedures and the signalmen were using their own interpretations of what should happen. Now, with a procedure in place for the last 18 months or so, Network Rail are claiming that the down time of the barriers has been reduced by one to one and a half minutes per hour. Coupled with a reduced road traffic flow and the reduction of the partly implemented 3 trains per hour service in each direction back down to 2, it is good(ish) news for motorists.

However, there are clouds on the horizon. GWR are considering enhancing the rush hour service. They still have medium term plans for a full reintroduction of 3 tph with a published long term aspiration for 4 tph. A new body and Transport for South East have expressed a wish for inter-city services 'east of Guildford'. Further in the future, if the proposed south-east rail route into Heathrow is approved (this would run alongside the M25 mostly along a disused trackbed), this could further exacerbate the situation. With one of these services proposed to run from Guildford into Heathrow, it would be easy with bi-mode trains to envisage a Heathrow to Gatwick service via Reigate. So in the very long term there could be three times the number of trains over the level crossing as today albeit with a huge benefit for rail passengers.

It is quite possible that none of these services will materialise in the next few decades. But what if they do? What provision is being made for the road users if the rail traffic does increase significantly? The answer is absolutely nothing. There are no plans whatsoever to deal with the possible outcome.

The answer should be two studies; one into the traffic flow over the crossing and the second a review of a plan to abolish the level crossing either by a bridge or a tunnel. There was a study for a bridge some time back which decided that it was too difficult. But there has been new thinking since then and it is worth looking at again. So should these extra train services happen, there would be a plan of action with approximate costs.

The Transport Committee submitted question to Surrey County Council highways about making the pedestrian crossing near the level crossing traffic light controlled. Without going into detail (see the website About>transport Committee and click on the link to Reigate Level Crossing for the full story) the response from the Highways department was a poorly thought out set of reasons why this was not possible which we believe amounted to a 'please go away, we are not interested'. Attempts by the Community Rail Partnership to have a dialogue with the Highways department have been ignored which only strengthens out opinion about their complete lack of interest.

What is Happening with Reigate Level Crossing? (continued)

It is hard to predict the future. But to have absolutely no plans for moderate increases in the number of trains over the level crossing and the resultant traffic jams is culpable.

It is also significant that no air pollution studies have been carried out in the region of the level crossing.

Proposed Park Hall Road Alternative Provision (Special Needs) Campus

The Transport Committee has lodged an objection to the proposed Alternative Provision Campus in Park hall Road, Reigate on the grounds the unsuitable location from a traffic perspective. With the vast majority of the attendees arriving by road, Brokes Road is not a wide road and would become congested. The road would have to be made a non parking zone putting extra pressure on parking in Brokes Crescent in particular.

Reigate Hill already gets very congested and would become even more so as squadrons of vehicles arrive together. The west end of Brokes Road and Beech Road are private roads and would become 'rat-runs' to avoid traffic on Reigate Hill. The Park Hall Road site cannot accommodate many vehicles at the same time and grid-lock seems a likely outcome.

From a traffic perspective, this is a poorly thought out proposal.
